Guiding Principles

- Treatment is a priority over incarceration. This will require that we build sufficient
 community infrastructure (points 0 and 6) and develop sufficient space and programming
 options within the jail facility.
- 2. Develop Monroe County's justice system with a unique facility, while meeting constitutional and humanitarian requirements.
- 3. Address inequities in race, economic status, sexual orientation, and gender.
- 4. Reduce the number of people entering the criminal justice system and reduce recidivism for those who are/ were in the system.

- Request to add the words collaboratively, transparency and public safety.
 - o Collaboration and transparency in all areas.
 - o Public safety: stand- alone OR when appropriate
- Recommendation to go around the table to introduce committee members to the public
 - Look into getting nametags for committee members going forward

Discussion of Treatments

Committee members each discuss their ideas for treatment.

- Programming within the jail for re- entry
- Programming for employment as people exit jail
- Life skills programs
- Supervised parenting when appropriate, parenting classes
 - o Remember flexibility in programming
- Map/ outline → where does the criminal process begin
- Connect to intercepts: connection issues (time line getting people into treatment programs after being released from jail)
- Work with probation to look at successful past programs
- Programming for mental health and substance use
- Focus on diversion from jail rather than jail programs
 - o use people that are trained in mental health rather than jail employees
- Housing upon release from jail
- Work to shorten waiting period for treatment facilities
 - o use of ARPA funds
 - o include people that are involved in treatment facilities in discussions
- Diversion to What? (Document put out by Bazelon Center for Mental Health Law, September 2019)
 - Housing support
 - o Peer services in jail
 - Supportive employment
- Assertive Community Treatment
- Stay updated on legislation on bi annual budget session and how that will provide resources to counties
- Who do we work with? How do we avoid becoming the sole funding source?
 - o discuss the process side more
- Keep flexibility in programming
 - o process for review and evaluation
 - RFP
- Scattered site services
 - o People do better when integrated in their community
- Container homes
 - Big shipping containers that can be converted into small homes

- Tailor jail programs for those who are actually in jail and who need to be in jail, and community programs for to others.
- Mapping approach
- Self-help legal center
 - o Legal advice to those that are self-represented
 - o Limited scope advisability
 - available to people in jail as well

Public Comment

David Garcia: NAACP

- Encouraged monitored and cooperative effort to involve all levels of government (city, state, federal)
- Expressed concern for homeless population

Debbie Fish: Hope for Prisoners Task Force, Care not Cages

- What is the estimated cost of renovating the current facility?
- Zero intercept
 - A local minister is looking to build a dream center; invite him to come and speak at a meeting
- Courage to change sober living has proven effectiveness
 - o could use another facility to serve more people
- Care not cages signed up to be surveyed
- What does CJRC stand for? Community Justice Reform Committee
 - o Reform does not always mean better

Unknown Speaker: Care not Cages

• Incarceration limits access to treatment

Edie Barbieu: Care not Cages

- Encouraged shift in discussion to community response rather than jail
- A jail campus would divert energy and resources away from the facilities/ programs already in Bloomington.
 - Physically accessible
 - o Familiar with this community's needs
- Shared direct responses from Care not Cages open meeting regarding new jail proposal
 - Addiction/ harm reduction
 - o Funding for Courage to Change Sober Living
 - Improved reliable access to work/ transit access

Max Smith: Care not Cages

- Formerly incarcerated; previously on the board of New Leaf New Life
- Get to people before they are incarcerated.
 - o Lack of community, mental health issues, etc. is why people end up incarcerated
- Social work should be done by social workers, not the police.
- Feels there is wasted space in the current jail
- Encouraged spending less money to fix this jail rather than spending more money to build a new jail

Maggie: Care not Cages

- What specifically is wrong with the current jail and how much exactly it would cost to fix?
- Coupling jail and treatment reinforces mental health as criminal
- Most people on committee are not involved in treatment in this community; bring in the people that are

Dave Jones: NAACP

- Happy with treatment discussion,
- What are the steps before intercept zero?
 - o Youth treatment/ programs

Unknown Speaker: Care not cages

- Why have we not estimated the cost to update the new facility?
- What budgetary provisions have we made to pay back interest for this bond?

Bren Thomas: Care not Cages

- Concerned about land/ location
- Jail is always isolating & moving it away from the community would make it even more so.
- How would transit for families work?
- Environmental study on the buildability of the site due to water runoff has not been completed
 - Hopes we would hold off on purchase of land until then
