- Designate individuals from Monroe County government to work closely with the NAACP to analyze data.

Recommendations from meeting with Board of Judges- Councilor Wiltz

- Co-locate courts and court administration with the jail.
- Locate jail as close to downtown services and bus lines as is possible.
- Larger court rooms
- Be specific when discussing treatment; do not lump all treatment into one category.
