SBA Offers Disaster Assistance to Businesses and Residents of Indiana Affected by Severe Storms and Tornadoes

WASHINGTON – Indiana businesses and residents affected by severe storms and tornadoes on June 25 are eligible to apply for low-interest disaster loans from the U.S. Small Business Administration, <u>SBA</u> <u>Administrator Isabel Casillas Guzman</u> announced today.

Administrator Guzman made the loans available in response to a letter from Indiana Governor Eric J. Holcomb on July 17 requesting a disaster declaration by the SBA. Businesses and residents in the declared area can now apply for low-interest disaster loans from the SBA. The declaration covers Monroe and Vigo counties and the adjacent counties of Brown, Clay, Greene, Jackson, Lawrence, Morgan, Owen, Parke, Sullivan and Vermillion in **Indiana**, and Clark and Edgar in **Illinois**.

"The SBA is strongly committed to providing the people of Indiana with the most effective and customerfocused response possible to assist businesses of all sizes, homeowners and renters with federal disaster loans," said Guzman. "Getting businesses and communities up and running after a disaster is our highest priority at SBA."

The SBA will open a Disaster Loan Outreach Centers (DLOCs) at the Ivy Tech Community College, in Terre Haute, and the Frank Southern Ice Arena, in Bloomington, to assist businesses and residents complete their disaster loan application, accept documents, and provide updates on an application's status. Walkins are accepted, but you can <u>schedule an in-person appointment at an SBA Disaster Loan Outreach Center</u> in advance. The Center's hours of operation are as follows:

"Businesses and private nonprofit organizations may borrow up to \$2 million to repair or replace disasterdamaged or destroyed real estate, machinery and equipment, inventory, and other business assets," said SBA's Indiana District Director Stacey Poynter. For small businesses, small agricultural cooperatives, small businesses engaged in aquaculture and most private nonprofit organizations, the SBA offers <u>Economic Injury Disaster Loans (EIDLs)</u> to help meet working capital needs caused by the disaster. EIDL assistance is available regardless of whether the business suffered any physical property damage.

Loans up to \$500,000 are available to homeowners to repair or replace damaged or destroyed real estate. Homeowners and renters are eligible for loans up to \$100,000 to repair or replace damaged or destroyed personal property.

"The opportunity to include measures to help prevent future damage from occurring is a significant benefit of SBA's disaster loan program, said <u>Francisco Sánchez, Jr., associate administrator for the Office of</u> <u>Disaster Recovery and Resilience at the Small Business Administration</u>. "I encourage everyone to consult their contractors and emergency management mitigation specialists for ideas and apply for an SBA disaster loan increase for funding."

Applicants may be eligible for a loan amount increase of up to 20 percent of their physical damages, as verified by the SBA for mitigation purposes. Eligible mitigation improvements may include a safe room or storm shelter, sump pump, French drain or retaining wall to help protect property and occupants from future damage.

Interest rates are as low as **4%** for businesses, **3.25%** for nonprofit organizations, and **2.688%** for homeowners and renters, with terms up to 30 years. Interest does not begin to accrue, and monthly payments are not due, until 12 months from the date of the initial disbursement. Loan amounts and terms are set by the SBA and are based on each applicant's financial condition.

Applicants may apply online and receive additional disaster assistance information at <u>sba.gov/disaster</u>. Applicants may also call SBA's Customer Service Center at (800) 659-2955 or email <u>disastercustomerservice@sba.gov</u> for more information on SBA disaster assistance. For people who are deaf, hard of hearing, or have a speech disability, please dial 7-1-1 to access telecommunications relay services.

The filing deadline to return applications for physical property damage is **<u>Sept. 16, 2024</u>**. The deadline to return economic injury applications is **<u>April 17, 2025</u>**.
