B. Commissioner Douglas (Vice-Chair)

- October is Domestic Violence Awareness Month; ADHD Awareness Month; LGBT History Month; Breast Cancer Awareness Month; Filipino American History Month
- Attended Monroe County NAACP event 70 Years Post-Brown: Looking to the Past,
 Transforming the Future part of committee hosting event
 - a) Great panel discussion including Frank Motley, J.D. and Vivian Bridgwaters-Gray discussing roll out of Brown v Board of Education and that not a lot has changed and things that were meant to be addressed by that ruling are still happening now; IU NAACP President DaJuan Pearson and Bloomington High School South senior Jael Davis shared their recent experiences in schools in Indiana; Jael Davis advocated for a racial discrimination justice policy to be added to the MCCSC Student Handbook and that passed last year

V. Old/Ongoing business

A. Profile Subcommittee (Commissioners Douglas, Otto, and Belton)

- Purpose: Elevating profile of Monroe County Women's Commission, who we are, and what we support
- Meets second Thursday of every month at 5:30pm
- Commissioners Otto and Douglas attended Indiana Commission for Women's
 Torchbearer Awards event; interesting to see award winners and their work (starting non-profits, supporting women, trauma care for women coming out of domestic violence situations) but also in the middle of a state with a supermajority that is not supporting women
 - a) Monroe County Women's Commission did not seem to be known or understood among this group
- Commissioner Douglas attended the 2024 Vi Taliaferro Dinner and spoke about the MCWC gender equity rubric under development
- No public comment presented yet at Board of Commissioner's meeting on MCWC work
- Hoosier Asian American Power (HAAP) is phone banking to get out the vote
- HAAP is also publishing candidate questionnaire responses from surveys sent to counties with high Asian American populations, governor candidates, and attorney general candidates
 - a) Responses from only 5 candidates disappointing because it shows how Asian Americans are not seen

B. Outreach Subcommittee (Commissioners Iruoje, Belton, and Hardesty)

- Purpose: Create and maintain programs that support our mission; current focus is web design camp
- Meeting on Mondays but do not have next meeting scheduled yet
- Web Design Camp still waiting to get feedback from IU General Counsel (last meeting in August)
- Health Fair event occurred at Banneker Community Center and community members were helped with health care checks thanks to Commissioner Belton for making that happen!
- C. Policy Subcommittee (Commissioners Sobiech, Hardesty, and Douglas)

- Purpose: Evaluate county policy using gender equity lens; current focus is jail
- Meets fourth Thursday of month at 5:30pm
- Meetings on hold until after Election Day but will pick up on gender equity rubric work then

D. Data Subcommittee (Commissioners Hingle and Sobiech)

- Purpose: Become more grounded in who we serve through data; current focus is creating survey
- Meets second Sunday of month at 3:30pm
