

ORDINANCE 2019 - 14

An ordinance to amend various traffic ordinances listed below in the Monroe County Code.

SECTION I

An ordinance to amend Ordinance 86-09 regarding regulatory speed conditions for vehicular traffic on designated roads, streets, etc., in Monroe County, Indiana.

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF MONROE COUNTY, BLOOMINGTON, INDIANA, AS FOLLOWS:

That Appendix A of Ordinance 86-09 is amended by the **deletion** of the following **30 mph speed limit** locations:

SECTION II

An ordinance to amend Ordinance 86-06 regarding regulatory stop conditions for vehicular traffic on designated roads, streets, etc., in Monroe County, Indiana.

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF MONROE COUNTY, BLOOMINGTON, INDIANA, AS FOLLOWS:

That Appendix A of Ordinance 86-06 is amended by the **addition** of the following **stop** location:

- **Sherwood Drive for Broadway Avenue**
- **Broadway Avenue for Sherwood Drive**
- **Western Drive for Broadway Avenue**
- **Broadway Avenue for Western Drive**
- **McDougal Street for Hennessy Street**

SECTION 4: Any vehicle operator who is found to violate any provision of this ordinance commits a Class E Ordinance violation, and a Class D ordinance violation for each subsequent violation. The vehicle operator shall be fined in accordance with Monroe County Code Chapter 115.

SECTION III

An ordinance to amend Ordinance 86-11 regarding regulatory No Parking signs for vehicular traffic on designated roads, streets, etc., in Monroe County, Indiana.

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF MONROE COUNTY, BLOOMINGTON, INDIANA, AS FOLLOWS:

That Appendix A of Ordinance 86-11 is amended by the **addition** of the following **No Parking** (from here to corner) locations:

- **Calloway Court 10 feet from Calloway Street**
- **Calloway Street 10 feet from Derby Drive**
- **Calloway Street 10 feet from Jackson Creek Drive**
- **Carbury Court 10 feet from Derby Drive**
- **Cardinal Glen Drive 10 feet from Walnut Street Pike**
- **Citation Drive 10 feet from Derby Drive**
- **Derby Drive 10 feet from Sophia Court**

- Derby Drive 10 feet from Rhorer Rd
- Hummingbird Court 10 feet from Cardinal Glen Drive
- Keenland Court 10 feet from Derby Drive
- Manowar Court 10 feet from Keenland Court
- Sandpiper Drive 10 feet from Cardinal Glen Drive
- Sandpiper Drive 10 feet from Jackson Creek Drive
- Secretariat Court 10 feet from Derby Drive
- Sophia Court 10 feet from Jackson Creek Drive
- Sparrow Court 10 feet from Cardinal Glen Drive
- Winners Circle 10 feet from Derby Drive

SECTION 4: Any vehicle operator who is found to violate any provision of this ordinance commits a Class E Ordinance violation, and a Class D ordinance violation for each subsequent violation. The vehicle operator shall be fined in accordance with Monroe County Code Chapter 115.

SECTION IV

An ordinance to amend Ordinance 86-12 regarding regulatory yield conditions for vehicular traffic on designated roads, streets, etc., in Monroe County, Indiana.

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF MONROE COUNTY, BLOOMINGTON, INDIANA, AS FOLLOWS:

Appendix A of Ordinance 86-12 is amended by the **addition** of the following **yield** locations:

- **Anderson Road for Northshore/Low Gap Road**

SECTION 4: Any vehicle operator who is found to violate any provision of this ordinance commits a Class E Ordinance violation, and a Class D ordinance violation for each subsequent violation. The vehicle operator shall be fined in accordance with Monroe County Code Chapter 115.


