**RESOLUTION 2019-10**

**2019 TAX ABATEMENT COMPLIANCE FINDINGS**

**WHEREAS**, the Monroe County Economic Development Commission (MCEDC) has met for the purpose of reviewing Compliance with Statements of Benefits documentation submitted by companies holding tax abatements granted by Monroe County for certain increased assessed valuation of personal property and/or real property values due to investment in the County; and

**WHEREAS**, upon completion of its review, the MCEDC forwarded recommendations that the Monroe County Council regarding findings of compliance, said recommendations attached to this Resolution as Exhibit A; and
