Fund Name: Drug Free Community

Amount: \$89,495.90

Executive Summary: The CARES Board is the local coordinating council ("LCC") for Monroe County and the Monroe County Commissioners. Each county in Indiana has an LCC. These councils were established by executive order under Governor Bayh as part of the Drug Free Indiana mission to support and promote local efforts to prevent and reduce harmful involvement with alcohol and other drugs.

**B. 2016-2017 Memorandum of Understanding with Centerstone for
Thinking for a Change**

Fund Name: Community Corrections

Fund Number: 1122-005

Amount: \$17,250.00

Executive Summary: Centerstone has been conducting classes for Monroe County Probation/Community Corrections clients featuring the evidence-based program "Thinking for a Change" curriculum. "Thinking

for a Change" ("T4C") is an integrated, cognitive behavioral change program designed for offenders that includes cognitive restructuring, social skills development, and development of problem-solving skills.

The attached Memorandum of Understanding (MOU) between Centerstone and the Probation Department describes the 11th year of the program which will be funded by Community Corrections grant monies from the Indiana Department of Correction (IDOC). The MOU stipulates that Centerstone staff will conduct an assessment of referred probation clients to determine if T4C would be a timely and proper intervention. If other issues are identified, treatment referrals can be made.

Probation will reimburse Centerstone \$4.71 per each quarter (1/4) hour for each eligible T4C participant as the payer of last resort quarterly if funds are not received through Recovery Works or insurance options for identified participants; not to exceed \$17,250 annually. Payment is contingent on timely receipt of grant funds from the Indiana Department of Correction.

C. 2016-2017 Memorandum of Understanding for Functional Family Therapy Services from Functional Family Therapy Associates, Inc.

Fund Name: Community Corrections

Fund Number: 1122-005

Amount: \$17,250.00

Executive Summary: The Monroe County Court Probation Department ("Probation") recognizes the need for a systematic and evidence-based approach (Functional Family Therapy) for its adult and adolescent clientele and their families. There are currently funds (\$17,250) available through the Indiana Department of Correction (local Community Corrections grant) for providing Functional Family Therapy ("FFT") services for families referred by Probation. Monroe Circuit Court Probation agrees to compensate Functional Family Therapy Associates, Inc. for training and ongoing support of FFT services through local service providers as agreed upon.

Dr. Sexton will provide to the service providers:

1. Three (3) introductory webinars (1-1/5 hours each). This is done prior to the training day;
2. Three (3) 1 days training this year;
3. Five (5) additional webinars over the year;
4. Every other week 1 hour video consultation for the year;
5. Access to the FFT-Clinical Feedback System; and
6. Probation consultation as needed.

Dr. Sexton with participating FFT providers agree to allow probation management staff to audit, in person or online, quality and monitoring progress using the FFT-Clinical Feedback System and/or case team meetings.
